**O R D E R**  
**09-05-2022**

1. The appellant Shri Suruj Jamal is present.
2. The SPIO, O/o the Block Elementary Education Office, Barpeta Block, Distt. Barpeta is absent without any intimation.
3. From records it is seen that the appellant Shri Suruj Jamal on 07.10.2021 submitted one RTI application to the SPIO, O/o the BEEO, Barpeta Block on 07.10.2021 seeking certain informations related to Pithadi ME Madrassa, Barpeta, under the BEEO, Barpeta Block. On not receiving any response he submitted a 1<sup>st</sup> Appeal on 05.11.2021 and when he found no response from the FAA i.e. District Elementary Education Officer, Barpeta, he submitted a 2<sup>nd</sup> Appeal before this Commission on 18.12.2021.
4. In view of the above, the SPIO, Block Elementary Education Office, Barpeta Block, is directed to furnish informations to the appellant Shri Suruj Jamal within 15 (fifteen) days from the date of receipt of this order, free of cost. In case the informations are voluminous in nature then the first 50 (fifty) pages shall be given free of cost and the remaining pages by realizing photocopying charges from the appellant.
5. **The SPIO, O/o the Block Elementary Education Officer, Barpeta Block, Distt. Barpeta, is also directed to furnish a written statement explaining why penalty under Section 20(1) of the RTI Act, 2005, shall not be imposed on him/her for his/her failure to furnish the sought for information within the stipulated time period.**
