- 1. The appellant Shri Diganta Das is present.

As such, the SPIO/DGM, APDCL, Jorhat is directed to furnish the informations to the appellant Shri Diganta Das within 15 (fifteen) days from the date of receipt of this order, free of cost.
- 5. With the above order, this  $2^{nd}$  Appeal is hereby disposed of.
