O R D E R 07-04-2022

1. The appellant Shri Charan Prit Singh is present.

- 2. Shri Prasanta Kumar Das, Food Civil Supplies & Consumer Affairs Department, Kamrup (M) is present representing the Department on the basis of an order dated 05.04.2022 issued by the Deputy Director, Food Civil Supplies & Consumer Affairs Department, Kamrup (M). A copy of the said order has been provided for record. Shri Prasanta Kumar Das also submitted a written statement dated 05.04.2022 signed by the Deputy Director, Food Civil Supplies & Consumer Affairs Department, Kamrup (M).
- 3. From records it is seen that the appellant Shri Charan Prit Singh had submitted one RTI application to the Deputy Commissioner, Kamrup (M) seeking certain information related to a family identity card/ration card No. 122626, the card holder's, name being Shri Kamal Singh and the fair price shop owner's name Shri Mrigen Sutradhar of Kamrup (M) District. The said RTI application was transferred to the Deputy Director, Food Civil Supplies & Consumer Affairs Department, Kamrup (M), on 27.10.2021. On not receiving any response, the appellant submitted a 1st Appeal which was heard on 10.01.2022. In the order of the 1st Appeal hearing it has been mentioned that the Deputy Director, Food Civil Supplies & Consumer Affairs Department, Kamrup (M), had already provided the information directly to the petitioner vide letter No. KSL(M)28/2013/256 dated 05.01.2022. A copy of the said letter has been submitted along with the written statement for record.
- 4. On examination of the informations furnished to the appellant on 05.01.2022, it is seen that the Department has informed him that the card No. 122626 as mentioned in the RTI application is not available in the fair price shop of Shri Mrigen Sutradhar (FPS code 132200100544) and in the RCMS database as per an enquiry report of the Area Inspector, FCS & CA, Kamrup (M). The appellant was informed that as such the required informations are also not available in the RCMS database. It has been also said that the name of Shri Kamal Singh as mentioned in the RTI application (it being name of the card holder) is also not found as tagged with the fair price shop of Shri Mrigen Sutradhar.
- 5. Since the Public Authority, in this case the Deputy Director, Food Civil Supplies & Consumer Affairs Department, Kamrup (M), has very clearly stated that the informations sought by the appellant Shri Charan Prit Singh is not available in the official database, as such the Commission has no further role in this regard. The appellant is free to approach any other forum for redressal of his grievances, if any.
- 6. In view of the above, this 2nd Appeal is hereby disposed of without any order.
