O R D E R

1. The petitioner Sri Joydeb Das has filed one RTI petition before the PIO of Directorate of Vigilance & Anti Corruption, Srimantapur, Guwahati on 24.8.2021 seeking following information:
(a) Whether any anonymous complaint has been enquired or not, if enquired, please furnish whether any EO deputed.
2. On not being satisfied with the information received, the petitioner filed a complaint petition u/s 18(1) of the RTI Act, 2005 on 11.4.2022.
Accordingly, the matter was taken up for hearing.
3. The petitioner Sri Joydeb Das is present.
4. The Public Authority to be represented by SPIO, Directorate of Vigilance & Anti Corruption, is absent. However, the Superintendent of Police, Directorate of Vigilance & Anti Corruption has submitted a written statement dated 30.5.2022 wherein it is mentioned that the SPIO was suffering from illness and presently admitted at hospital for surgery for which the SPIO is unable to appear at the hearing.
5. The Deputy Inspector General of Police cum 1st Appellate Authority has also submitted a written statement dated 26.5.2022 wherein it is mentioned that the petitioner did not appeal before the 1st Appellate Authority, because of which the 1st Appellate Authority could not submit any written statement about the steps taken.
6. Since the SPIO is absent, the Commission has decided to hear the matter again after two months.
7. Fix next date of hearing.
