O R D E R

- The petitioner Sri Joydeb Das has filed one RTI petition before the PIO of Assam Food & Civil Supplies Corporation Ltd., Guwahati on 27.1.2022 seeking following information:
 - (a) Please furnish copy of audit report during the period 2016-17 to 2018-19.
 - (b) Please furnish in details of the procedure followed (relevant records)prior each expenditure made by the Administrative charge provided by the Government of Assam during the period 2019-20 to till date.
- 2. The PIO of Assam Food & Civil Supplies Corporation Ltd. then sent a letter to the petitioner on 1.3.2022 regarding the sought for information
- 3. On not being satisfied with the information received, the petitioner filed 1st appeal before the 1st Appellate Authority, Assam Food & Civil Supplies Corporation Ltd on 17.3.2022 and accordingly, reply was sent again by the PIO on 25.3.2022.
- 4. The petitioner then filed 2nd appeal before the Commission on 4.5.2022 and accordingly, the matter was taken up for hearing.
- 5. The petitioner Sri Joydeb Das is present.
- The Public Authority is represented by Smti Kirti Agarwal, Company Secretary & PIO, AFCSCL and she is accompanied by Sri Prafulla Kumar Saikia, Senior Executive Officer, AFCSCL.
- 7. The PIO had submitted a written statement dated 31.5.2022 which is taken into records.
- 8. At the hearing, the petitioner said that he has received the reply relating to question no.1 satisfactorily, however, regarding question no.2, the details of procedure and details of the documents are not provided and whatever documents are provided are not fully covered.
- 9. The SPIO along with the Senior Executive Officer mentioned that initially they had some problem in interpreting "terminology" of question no.2 i.e., details of the procedure.

However, they have no problem in providing whatever documents the petitioner desires, but requested the petitioner to submit a list of documents and after receipt of the petition they will take around ten days to collect and compile the documents and they will intimate accordingly to the petitioner to come and inspect the documents in their office and collect them.

- 10. The Commission agrees to it and directs the SPIO to fix a convenient date with the petitioner and necessary action be taken to provide the information to the petitioner.
- **11.** In view of the above, the case is disposed off.
