**O R D E R**  
**30/06/2022**

1. The petitioner Sri Harinarayan Pathak has filed a RTI petition before the SPIO, O/o the Managing Director, Assam Industrial Infrastructure Development Corporation (AIIDC), Industrial Estate, Bamunimaidam, Guwahati on 30.3.2022 seeking following information:
  - (i) Copy of the Public document vide letter no. CI.133/2007/213 dated 1.4.2010 issued from the Officer on Special Duty (O.S.D) Smti.Malika Medhi, ACS, Industries & Commerce Department, Dispur addressed to the Managing Director, AIIDC, IE, Bamunimaidam, Guwahati with subject Payment of Advance for Guwahati Municipal Corporation to purchase of land for exhibition cum Trade Centre at Guwahati.
  - (ii) Action taken report in Documentary Proofs including respective file notings, in respect of the Public Documents, as referred to at the query no.(i) above.
2. Reportedly on not getting any information, the petitioner filed 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority, AIIDC, IE, Bamunimaidam, Guwahati on 5.5.2022 and then he filed 2<sup>nd</sup> appeal before the Commission on 13.6.2022.  
Accordingly, the matter was taken up for hearing.
3. The petitioner Sri Harinarayan Pathak is absent.
4. The Public Authority is represented by Sri Ritumoni Pachani, SPIO & GM, AIIDC.
5. The SPIO in its written statement dated 28.6.2022 stated that the 1<sup>st</sup> appeal hearing was held on 22.6.2022 at 3.15 PM i.e., one month fifteen days after the 1<sup>st</sup> appeal petition which is contrary to the provision of the RTI Act,2005. It is impressed upon the SPIO.
6. **It is impressed upon the SPIO and 1<sup>st</sup> Appellate Authority to ensure that the 1<sup>st</sup> appeal petition be taken within one month. Had it been taken within one month, the petitioner should not have filed 2<sup>nd</sup> appeal petition and the Commission should not have wasted the time on the 2<sup>nd</sup> appeal hearing.**
7. As regards to point no.1 of the RTI petition, the Commission directs the SPIO to put more efforts to trace the letter and furnish the same to the petitioner.
8. The case is disposed off.
