O R D E R 30/06/2022

1. The petitioner Md. Tousif Hussain Reza has filed one RTI petition before the In-Charge of the office, O/o the PCCF & HoFF, Aranya Bhawan, Panjabari, Guwahati on 9.3.2022 seeking some information about a plot of land measuring ten, covering by Dag No.174 of KP Patta No.5 of Revenue Village Amsing Nonke (Non Cadastral), Under mouza Panbari Sonapur Circle in the district of Kamrup(M) Demarcated and marked boundaries of the said land with "Pillars and Post details with latitude and longitude.

Please provide the following information:

- (i) Please provide the daily progress made on the above mentioned applications.
- (ii) Please provide the thematic satellite image of the map for the above mentioned latitude and longitude.
- (iii) Please clarify if the mentioned latitudes and longitudes falls under forest boundaries.
- (iv) Please state the reasons behind delaying the process and holding the mentioned application.
- (v) Please provide the date and time required to complete disposal of the application.
- (vi) Please provide the steps taken to ease the process of the business in the terms of the documentation.
- (vii) Name and designation of the officials who have considered my application and the number of days it was lying with each official during the period.
- (viii) Provide copies of the file noting indicating the consideration of my application from the date of receipt till date by the concerned officials.(I would also like to inspect the documents related to each case.)
- (ix) Copy of the rules/regulations/orders/citizens charter which lay down the timeline for disposal of the matters.
- (x) Name and designation of the officials who are responsible for dereliction of duty for delaying my application in violation of relevant rules/regulations/ orders. If applicable
- (xi) (a) Date by when action would be completed in my case?
 - (b) Period for which information asked for 1987-2022.

- 2. Reportedly on not getting any information, the petitioner filed 1st appeal before the 1st Appellate Authority, O/o the PCCF & HoFF, Aranya Bhawan, Panjabari, Guwahati on 26.4.2022.
- 3. Then he filed 2nd appeal before the Commission on 9.6.2022 and accordingly the matter was taken up for hearing.
- 4. The petitioner Md. Tousif Hussain Reza is absent. However, he has sent an email dated 30.6.2022 stating that the Forest Department has given some information and requested him for some more time in giving the remaining information. Basing on that, he requested before the Commission to adjourn the hearing.
- 5. The Public Authority is represented by Sri Suhas Kadam, IFS, SPIO cum DCF, O/o the PCCF & HoFF, Assam and he is accompanied by another J.R.Das, SPIO cum ACF, O/o the Divisional Forest Officer, Kamrup East Division, Basistha.
- 6. The SPIO, O/o the PCCF & HoFF, Panjabari, Guwahati as well as the SPIO, O/o the Divisional Forest Officer, Kamrup East Division, Basistha, Guwahati has submitted two written statement wherein it is stated that they have given the available information on transfer of the RTI petition from SPIO, O/o the PCCF & HoFF, Panjabari to SPIO, O/o the Divisional Forest Officer, Kamrup East Division, Basistha, Guwahati vide letters no, B/KE/RTI/Tousif Hussain/3110 dated Guwahati 2.5.2022 and B/KE/RTI/Tousif Hussain/7602-03 dated 29.6.2022.
- 7. As regards to point no.8 of the RTI petition, the SPIO has asked the petitioner to visit their office and inspect the documents.
- 8. In light of the reply submitted by the SPIOs and prayer submitted by the petitioner, the Commission directs the petitioner to visit the respective office and obtain the remaining information.
- 9. The case is disposed off.
