ORDER 28/06/2022

- The petitioner Smti Diphikha Mahanta has filed one RTI petition before the PIO, O/o the Commissioner of Police, Karmup (M), District, MG Road, Panbazar, Guwahati 01 on 7.3.2022 seeking some information as per enclosures (copy enclosed).
- Reportedly on not getting any information, the petitioner filed 1st Appeal before the 1st Appellate Authority, O/o the Commissioner of Police, MG Road, Panbazar, Guwahati 01 Assam on 18.4.2022 and then she filed 2nd appeal before the Commission on 23.5.2022.
 - Accordingly, the matter was taken up for hearing.
- 3. The petitioner Smti Dipshikha Mahanta is present.
- 4. The SPIO & Deputy Commissioner of Police (Admn.), Panbazar, Guwahati has submitted a written statement dated 24.6.2022 wherein he has requested before the Commission to exempt him for personal appearance and in the written statement the SPIO also mentioned that the detailed information on case number and IPC Section of Law of Sonapur P.S. for the period from 1.1.2020 to 1.1.2022 amounting to twenty five pages had been provided to the petitioner.
- 5. The SPIO have also mentioned the letter of Officer-in-charge of Sonapur Police Station forwarded to the Additional Commissioner of Police (Admn.), Commissionerate of Police, Guwahati City dated 22.6.2022 wherein it is stated that the Khatian register is a confidential record keeping document relating to cases of a police station, where details of the cases registered in a P.S. were recorded. So details of such confidential register could not be provided. The names and addresses of the complainant and the accused persons with regard to the cases registered could not be furnished as well.
- 6. The petitioner said that she has received the detailed list of the case number and the IPC section, but as mentioned by the Officer i/c, the name, address etc. is not given.
- 7. In light of the above, the case is disposed off.
