## ORDER 27/06/2022

- 1. The petitioner Sri Sujit Dey has filed one RTI petition before the PIO, O/o the Deputy Commissioner, Karimganj on 3.1.2022 seeking following information: Concerned Department: O/o the DC, Karimganj, R.K.Branch (Land Record)
  - (i) Action taken and present status of the Public Representation dated 20.11.2021 received by your office on 29.11.2021 by post demanding Survey of elam Mouza Bandarkuna Kitte Uttarbandarkuna be provided.
  - (ii) All the relevant office notes/files notes, communication made and/or received till date in respect of the said Public Representation dated 20.11.2021 received by your office on 29.11.2021 by post demanding Survey of elam Mouza Bandarkuna Kitte Uttarbandarkuna be provided.
- Reportedly on not getting any information, the petitioner filed 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority, O/o the Deputy Commissioner, Karimganj on 14.2.2022 and then he filed 2<sup>nd</sup> appeal before the Commission on 6.4.2022. Accordingly, the matter was taken up for hearing.
- 3. The petitioner Sri Sujit Dey is absent. However, he has sent an email dated 26.6.2022 wherein he has mentioned that due to various personal constraints he is unable to attend the hearing and hence requested before the Commission to pass an appropriate order.
- 4. The Public Authority to be represented by SPIO, O/o the Deputy Commissioner, Karimganj is absent. However, the SPIO of Deputy Commissioner, Karimganj has submitted a written statement dated 17/6/2022 wherein it is mentioned that Assistant Settlement Officer of Nilambazar has already furnished the sought for information to the appellant on 1.2.2022.

The SPIO in his written statement also mentioned that the ADC & SPIO, Karimganj has requested the RTI applicant to attend the hearing on 11.3.2022 at ADC & SPIO's Chamber, D.C's Office Karimganj vide letter no. KMJ.76/2021/122 dated 17.2.2022 against the 1<sup>st</sup> appeal petition dated 14.2.2022, but the appellant did not appear at the hearing without any reason thereof.

- 5. In light of the above, <u>the Commission directs the 1<sup>st</sup> Appellate Authority, O/o</u> <u>the Deputy Commissioner, Karimganj to fix another date with the petitioner</u> <u>to inspect and collect the documents from their office and dispose the</u> <u>case.</u>
- The case is disposed off. Authenticated copies to be given to all concerned.
