ORDER 28/06/2022

- 1. In continuation of earlier order dated 10/3/2022, the matter was taken up for hearing.
- 2. The petitioner Sri Joydeb Das is present.
- 3. The Public Authority is represented by Sri Dwijen Kakati , Consultant & SPIO, RERA and he is accompanied by Smti Kanchana Mahanta, Ex SPIO, RERA, Assam.
- 4. The Ex SPIO of Real Estate Regulatory Authority, Khanapara, Assam has submitted a written explanation before the Commission on 30.3.2022 which is taken into records.
- 5. At reply to point no.1, the Ex SPIO stated that she could not justify it as per Section 21 and 22 of the Real Estate (Regulation and Development) Act, 2016 and further about the qualification certificate, the Ex SPIO stated that she has contacted the Dealing Assistant for the information and in response to that he had submitted a photocopy of notesheet in this regard. But the office could not provide her the documents relating to copy of sanctioning post of consultant and copy of educational qualification.

The Commission accepts the prayer.

- 6. The petitioner raises issue on the statement of the Ex SPIO which *quote* the complainant being a habitual and professional RTI activist, it may be a deliberate attempt on his part to mislead the Commission *Unquiote to* which the Ex SPIO stated that it was inadvertently mentioned and she regrets it.
- 7. In light of the above, the Commission accepts the written explanation of the Ex SPIO and disposes the case.
- 8. The case is disposed off.
