O R D E R 23/06/2022

- 1. The petitioner Sri Harinarayan Pathak has filed one RTI petition before the SPIO, Political Department, Janata Bhawan, Dispur, Guwahati on 7.1.2022 seeking following information:
 - (i) Complete File Notings with relevant PUBLIC DOCUMENTS (IF ANY) in respect of Diary No.705 dated 16.3.2004, Marked in favour of the Supdt., Political (Vigilance) in regards to U/O No. 13/04, Dated 29.3.2004, being endorsed from Industries & Commerce Department, Dispur.
- 2. The Deputy Secretary to the Govt. of Assam, Political (Vigilance Cell) Department, Dispur forwarded the RTI petition to the SPIO of Political Department, Dispur on 24.2.2022.
- 3. Reportedly on not getting any information, the petitioner filed 1st appeal before the 1st Appellate Authority, Home & Political Department, Janata Bhawan, Dispur, Guwahati on 26.2.2022 and then he filed 2nd appeal before the Commission on 6.5.2022.

Accordingly, the matter was taken up for hearing.

- 4. The petitioner Sri Harinarayan Pathak is present.
- 5. The Public Authority is represented by Sri Tapash Gupta, Under Secretary & SPIO, Political Department and he is accompanied by Dibakar Swargiary & PIO, Political Department.
- 6. The Under Secretary to the Govt. of Assam & SPIO, Political Department, Dispur submitted a written statement dated 22.6.2022 wherein it is mentioned that without specificity of the information they are not in a position to provide the information.

The petitioner is giving the diary number, but with the diary number they are not in a position to trace out the file.

They have also intimated the petitioner about the sought for information vide letter no.PLA(V)08/2022/4 dated 10.3.2022.

- 7. In light of the above, the Commission directs the petitioner to furnish some details in helping the SPIO to trace out the file.
- 8. The Case is disposed off.
