**O R D E R**  
**23/06/2022**

1. The petitioner Sri Harinarayan Pathak has filed one RTI petition before the SPIO, O/o the Chief Secretary, Govt. of Assam, Dispur, Guwahati on 15.3.2022 seeking following information:
  - (i) Copy of the memorandum as received by the Chief Secretary, Govt. of Assam, Dispur being submitted by the ACS Officer's Association in regards to the manhandling of Sri Bibhash Medhi, ACS, Election Officer, South Salmara, Mankachar District by Sri Pranjit Lakhar, O.C., Satgaon Police Station, Guwahati while to lodge a complaint petition regarding Land Grabbing Case on 7.3.2022.
  - (ii) Action taken report in respect of the Memorandum, as referred to at the Query No.1 above, Supported by Documentary Proofs.
2. The Staff Officer to Chief Secretary, Chief Secretary's Office, Dispur, Guwahati transferred the RTI petition to the Principal Secretary to the Govt. of Assam, Home Department, Guwahati 6 on 17.3.2022. The Under Secretary to the Govt. of Assam, Political (A) Department, Dispur forwarded the RTI petition to the Director General of Police, Ulubari Guwahati on 7.4.202 for taking necessary action.
3. The Under Secretary to the Govt. of Assam & SPIO, Political Department sent a letter to the petitioner on 12.4.2022 furnishing the sought for information.
4. Reportedly on not being satisfied with the information received, the petitioner filed first appeal before the 1<sup>st</sup> Appellate Authority, Home & Political Department, Janata Bhawan, Dispur, Guwahati on 18.4.2022 and then he filed 2<sup>nd</sup> appeal before the Commission on 20.5.2022.

Accordingly, the matter was taken up for hearing.
5. The petitioner Sri Harinarayan Pathak is present.
6. The Public Authority is represented by Sri Tapash Gupta, Under Secretary & SPIO, Political Department and he is accompanied by Dibakar Swargiary & PIO, Political Department.
7. The Under Secretary to the Govt. of Assam & SPIO, Political Department, Dispur submitted a written statement dated 22.6.2022 wherein it is mentioned that sought for information has already been furnished to the appellant on 12.4.2022.
8. The Commission accepts the written statement and disposes the case.
9. However, the petitioner has asked about various other memoranda submitted by the Association but they do not come under his RTI petition as pointed out by the SPIO.

10. In light of the above, the case is disposed off.
