**O R D E R**  
**24/06/2022**

1. The petitioner Sri Harinarayan Pathak has filed one RTI petition before the SPIO, O/o the Managing Director, Assam Industrial Development Corporation ( A Govt. of Assam Public Enterprise), Industrial Estate Bamunimaidam, Guwahati on 11.3.2022 seeking following information:
  - (i) Inspection of the following files and obtainance of the records including file notings as identified during the inspections:
    - (a) No. AIIDC/02/98-99; and
    - (b) No. AIIDC/282/2002.
  - (ii) Name in full of the official to whom appointed by the Govt. of Assam, Industries Commerce & P.E. Department, Dispur Guwahati for posting as the Managing Director, AIIDC, w.e.f. 1.3.2022 in documentary proof.
2. Reportedly on not getting any information, the petitioner filed 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority, AIIDC, Industrial Estate Bamunimaidam, Guwahati on 18.4.2022 and then he filed 2<sup>nd</sup> appeal before the Commission on 24.5.2022.

Accordingly, the matter was taken up for hearing.
3. The petitioner Sri Harinarayan Pathak is present.
4. The Public Authority to be represented by SPIO of Assam Industrial Infrastructure Development Corporation is absent .

However, the General Manager(Civil) & SPIO of AIIDC, IE, Bamunimaidam, Guwahati has sent an email dated 24.6.2022 wherein it is mentioned that a date was fixed by the First Appellate Authority for inspection of files on 23.6.2022 at 3:00 PM, on which the petitioner was present at their office and accordingly some part of the documents was provided to the applicant as identified by the petitioner with total 126 pages of documents.

The SPIO in his email also stated that the rest of the documents will be identified by the petitioner on subsequent time and will be provided to the applicant on 27.6.2022 as mutually and amicable agreed to.
5. The petitioner has submitted a prayer dated 23.6.2022 stating that inspection of the two number of files are done in presence of the SPIO, however due to insufficient time and other official work of the SPIO, the inspection of remaining files were not complete and as such the inspection for remaining files were fixed on 27.6.2022 for total inspection.

6. In light of the above, the case is disposed off.
