1. The petitioner Smti Dipshikha Mahanta has filed one RTI petition before the PIO, O/o the Principal Chief Conservator of Forests & HoFF, Panjabari, Guwahati on 15.11.2021 seeking following information:
(a) Information regarding the enquiry report submitted by Hemakanta Talukdar in respect of Black Board Frame Scam.
(b) Information regarding transfer of four employees of Forest Department namely Dalim Deka, Arup Kalita, Biren Baishya and Ranjit Dutta.
2. Reportedly on not getting any information, the petitioner filed 1st appeal before the First Appellate Authority, O/o the Principal Chief Conservator of Forests & HoFF, Panjabari, Guwahati on 14.2.2022 and then she filed 2nd appeal before the Commission on 2.5.2022.

Accordingly, the matter was taken up hearing.

3. The petitioner Smti Dipshikha Mahanta is present.
4. The Public Authority is represented by Sri Suhas Kadam, IFS, DCF, O/o the PCCF & HoFF & SPIO, O/o the PCCF & HoFF, Assam.
5. The SPIO has submitted a written statement dated 18.6.2022 wherein it is mentioned that the sought for information stating that the report is forwarded to the Government and under examination and he is not in a position to provide a copy.
6. The petitioner said that he could have atleast transferred this to the SPIO of concerned department.
7. In view of the above, the case is disposed off.
