O R D E R

- 1. The petitioner Sri Kirtikamal Bora has filed one RTI petition before the PIO, Directorate of Fisheries, Govt. of Assam, Meen Bhawan, Gopinath Nagar, Guwahati 16 on 15.11.2021 seeking following information in Assamese whose rough translation is given as follows:
 - (a) Details of Schemes implemented by Department of Fishers, Govt. of Assam from 1.1.2015 to 15.11.2021 and the amount implemented against the schemes
 - (b) Details of advertisement published against the scheme including number of photocopies of the advertisement.
 - (c) Provide photocopies of the contracts allotted to person for the scheme with their addresses along with the details of work orders.
 - (d) Provide photocopies along with completion certificate and utilisation certificate of the scheme implemented by Department of Fisheries, Govt. of Assam.
 - (e) Provide proof of payment and bank statement for amount disbursed to organisation in these schemes from 1.1.2015 to 15.11.2021.
- 2. Reportedly on not getting any information, the petitioner filed 1st appeal before the 1st Appellate Authority, Directorate of Fisheries, Meen Bhawan, Gopinath Nagar, Guwahati 16 on 4.4.2022 and then he filed 2nd appeal before the Commission on 16.5.2022.

Accordingly, the matter was taken up for hearing.

- 3. The petitioner Sri Kirtikamal Bora is present.
- 4. The Public Authority is represented by Smti Anushree Das, SDFDO/SPIO, Directorate of Fisheries and she is accompanied by Himangshu Baro, Project Manager and SPIO, Assam Fisheries Development Corporation Ltd.
- 5. The First Appellate Authority has submitted a written statement dated 18.6.2022 wherein it is mentioned that the information sought by the petitioner is voluminous and scattered over many files, so they wanted the petitioner to come and inspect the documents but the petitioner did not turn up.
- 6. In light of it, the Commission directs the SPIO to keep the file in readiness and inform the date and time to the petitioner to come and inspect and collect the documents on payment.
- 7. In light of the above, the case is disposed off.
