O R D E R 21/06/2022

- The petitioner Sri Kirtikamal Bora has filed one RTI petition before the PIO of SPIO, Directorate of Land Records & Survey, Rupnagar, Guwahati on 15.11.2021 seeking following information in Assamese whose rough translation is as follows:
 - (a) Copy of Janasanyog Advertisement for filing up Khalasi post during the tenure of Sri Madan Chandra Deka
 - (b) Photocopies of name, address and phone numbers who have applied for the fourteen regular post of Khalasi during the tenure of Sri Madan Chandra Deka.
 - (c) List of selected candidates against fourteen regular post of Khalasi during the tenure of Sri Madan Chandra Deka.
- 2. In reply to that, the i/c Director of Surveys, Assam, Rajahnagar Dakhingaon, Guwahati sent a letter to the petitioner on 27.12.2021 furnishing the sought for information.
- Reportedly on not being satisfied with the information received, the petitioner filed 1st appeal before the 1st Appellate Authority, O/o the Director of Land Records & Survey, Govt. of Assam, Rupnagar, Guwahati on 31.1.2022 and then he filed 2nd appeal before the Commission on 16.5.2022.
 - Accordingly, the matter was taken up for hearing.
- 4. The petitioner Sri Kirtikamal Bora is present.
- The Public Authority is Sri Arup Jyoti Hazarika, SPIO, O/o the Director of Land Records & Surveys etc. Assam and he is accompanied by Indrajit Das, Assistant Director of Surveys.
- 6. The SPIO has submitted a written statement dated 18.6.2022 which is taken into records. The SPIO stated that the matter does not belong to his department and hence the petition was transferred to the i/c Joint Director of Surveys, Assam.
- 7. From the records it is seen that the reply has been submitted by the i/c Joint Director of Surveys to the Assistant Inspector General of Registration, Director of Land Records & Surveys etc. Assam, Rupnagar, Guwahati on 20.6.2022 wherein it is mentioned that:-

<u>Reply to point no.1 of RTI petition</u>: The process for filing up the 14 nos. of temporary field Khalasi to permanent post is not taken up in the office of this undersigned. So providing advertising copy does not arise.

Reply to point no.2 of the RTI petition: Does not arise.

<u>Reply to point no.3 of the RTI petition</u>: Does not arise.

 Therefore, the Commission directs the SPIO, O/o the Director of Land Records & Survey/ i/c Joint Director of Surveys, Assam to mark a copy of this letter to the petitioner. In light of the above, the case is disposed off.
