- 1. The petitioner Sri Ranjan Roy has filed one RTI petition before the Executive Officer, Silchar Municipal Board, Silchar, Cachar, Assam on 15.12.2021 seeking following information:-
 - (i) Please provide me the details of allocation of fund's for the purchase of office stationary and maintenance received from 13th,14th and 15th Finance Commission.
 - (ii) Please provide me the actual position of fund received from 13th, 14th and 15th Commission(10%).
- Reportedly on not getting any information, the petitioner filed 1st appeal before the Deputy Commissioner, Silchar, Cachar, Assam on 18.1.2022 and then he filed 2nd appeal before the Commission on 7.3.2022.

Accordingly, the matter was taken up hearing.

- 3. The petitioner Sri Ranjan Roy is absent without any intimation.
- 4. The Public Authority to be represented by SPIO, Silchar Municipal Board is absent. However the SPIO has sent a prayer dated 16.6.2022 stating that due to communication disruption, he is unable to attend the hearing.
- 5. The First Appellate Authority i.e., Additional Deputy Commissioner, Cachar, Silchar has sent a letter dated 13.5.2022 wherein it is mentioned that the information has already been given to the petitioner by the PIO of Silchar Municipal Board vide letter no. SMG/RTI.2/2021-22/02 dated 4.4.2022.

In the letter of the SPIO, it is mentioned that there is no fund allotted for purchase of Office stationary and maintenance received under the award of 13th,14th and 15th Central Finance Commission and the actual position of fund received under 13th,14th and 15th Central Finance Commission (10%) is not available.

- 6. The Commission accepts the reply and disposes the case.
- 7. In light of the above, the case is disposed off.
