O R D E R 17/06/2022

- 1. The petitioner Sri Kalyan Kumar has filed one RTI petition before the PIO O/o the Director, Accounts & Treasuries of Assam, Kar Bhawan, Dispur, Guwahati on 7.2.2020 seeking following information:
  - (i) How many employees of Central Jail, Silchar drew Salary from Treasury Office, Silchar for the month of February, 2012?
  - (ii) Name the employees of Central Jail, Silchar who drew salaries from Treasury Office, Silchar for the month of February, 2012?
  - (iii) Did any employee by name Sri Kalyan Kumar (Assistant Jailor) of Central Jail, Silchar draw salary from Treasury Office, Silchar for the month of February 2012?
  - (iv) If yes then what amount did he drew? If no then why?
  - (v) If no then was any non-drawal certificate issue in this regard? Furnish the copy of the non drawal certificate if issued.
- 2. The Joint Director Accounts & Treasuries, Assam, Dispur forwarded the RTI application to the Treasury Officer, Cachar Treasury, Silchar on 21.8.2020 to take necessary action.

The Treasury Officer, Cachar Treasury, Silchar forwarded the RTI application to the Superintendent, Central Jail, Silchar on 23.8.2020.

3. The Superintendent of Central Jail Silchar sent a letter to the Treasury Officer, Cachar, Silchar on 25.9.2020 furnishing the sought for information and the Superintendent, Central Jail, Silchar marked a copy to the petitioner.

The Treasury Officer, Cachar Treasury, Silchar sent a letter to the petitioner on 30.9.2020 furnishing the sought for information.

4. On not being satisfied with the information received, the petitioner filed a complaint petition before the PIO, O/o the Director of Accounts & Treasuries of Assam, New Kar Bhawan, Dispur, Guwahati on 7.11.2020 and then he filed complaint petition before the Commission on 1.3.2022.

Accordingly, the matter was taken up for hearing.

5. The Treasury Officer of Cachar Treasury, Silchar has submitted a written statement dated 13.5.2022 which is taken into records.

The Superintendent of Central Jail, Silchar has also submitted another written statement dated 16.6.2022 which is taken into records.

- 6. The petitioner Sri Kalyan Kumar is absent. However he has sent an email dated 16.6.2022 wherein he has mentioned that he has got reply to only one question of his RTI petition.
- However, the Commission on perusing the reply of the Superintendent of Central Jail Silchar vide letter no.SCJ.36/2020/1670 dated Silchar 25<sup>th</sup> September,2020

reply to all the questions are given and copy of the letter was also marked to the petitioner.

- 8. The Commission accepts the reply and disposes the case.
- 9. The case is disposed off.
