O R D E R 17/06/2022

- 1. The petitioner Sri Nityananda Kaman has filed one RTI petition before the PIO of Superintendent of Police, Dhemaji on 12/2/2021 seeking some information on issue of notice to him in connection with Gogamukh PS Case no.17/ and the exception of the final report by Supervising Officer and to know whether it was approved as per rules and regulations.
- 2. The Deputy Superintendent of Police (HQ) Dhemaji cum PIO has furnished a reply to the petitioner on 29.10.2021.
- 3. The petitioner then filed 2nd appeal before the Commission on 1.2.2022 stating that he was given false information by the SPIO as it is in contradiction of the information that he got from the Judicial Magistrate.

Accordingly, the matter was taken up for hearing.

4. The petitioner Sri Nityananda Kaman is absent. However he has sent an email stating that he is not able to attend the hearing because of the grim flood situation in the district and he has also enclosed a written statement.

In his written statement, he has raised issues/asked questions how the Superintendent of Police, Dhemaji issued reminder, without issuing notices at first

Again, how the Additional SP gave approval submission of the final form without the recommendation of the Circle Officer.

- 5. These are his claims/questions which is beyond the jurisdiction of the Commission.
- 6. The Public Authority to be represented by SPIO, O/o the Superintendent of Police, Dhemaji Assam is absent. However, the SPIO has sent an email stating that the post of Additional Superintendent of Police cum SPIO is lying vacant since last one month.

This is not an acceptable prayer as some other officer could have been designated as SPIO during this period.

- 7. As per the mandate, the Commission is concerned with the supply of the information. If the SPIO has given false information and the petitioner has documents/proofs to counter, he may take remedial measures at proper forum.
- 8. In light of the above, the case is disposed off.
