1. The petitioner Sri Joydeb Das has filed one RTI petition before the PIO of Directorate of Welfare of Plain Tribes and Backward Classes, Rukmininagar, Dispur on 27.1.2022 seeking following information:
(a) Please furnish in details of the statement of scheme implemented of "Book Bank for Scheduled Tribe(ST) students" during the period 2012-13 to 2015-16 along with copy of NIT, Newspaper advertisement, Comparative Statement, Work Order and Bill/
Name of the scheme, Nos. of item procured till date, Nos. of item distributed till date, fund involved and fund released.
2. Reportedly, on not getting any information, the petitioner filed 1st appeal before the 1st Appellate Authority, Directorate of Welfare of Plain Tribes and Backward Classes, Rukmininagar, Guwahati on 16.3.2022 and then he filed 2nd appeal before the Commission on 4.5.2022.
Accordingly, the matter was taken up for hearing.
3. The petitioner Sri Joydeb Das is present.
4. The Public Authority to be represented by SPIO, Directorate of Welfare of Plain Tribes and Backward Classes is absent
5. The petitioner stated that name of the scheme is not mentioned and details of number of books distributed till date is not given.
6. The SPIO has submitted a written statement dated 8.6.2022 giving the details except the names of the scheme and number of books distributed till date.
7. In light of the above, the Commission orders that name of the scheme to be intimated and copy of distribution receipt also to be given to the petitioner within fifteen days.
8. In view of the above, the case is disposed off.
