1. The petitioner Smti Dipshikha Mahanta has filed a RTI petition before the PIO, O/o the Assam Cricket Association, Barsapara on 20.12.2021 seeking four numbers of information as per enclosures (copy enclosed).
2. Reportedly on not getting any information, the petitioner filed 1<sup>st</sup> Appeal before the 1<sup>st</sup> Appellate Authority, O/o the Assam Cricket Association, Barsapara on 7.2.2022 and then she filed 2<sup>nd</sup> appeal before the Commission on 23.5.2022.

Accordingly, the matter was taken up for hearing.

3. The petitioner Smti Dipshikha Mahanta is absent without any intimation.
4. The Public Authority to be represented by SPIO, O/o the Assam Cricket Association, Barsapara is absent without any intimation.
5. On perusal of the RTI petition, it is seen that the petitioner has mentioned her address as Mahapurush Srimanta Sankardev Path, P.O & P.S. Dispur, Guwahati, 781005, Dist. Kamrup(M), Assam but in her 2<sup>nd</sup> appeal she has mentioned her address as DY 365, Brahmaputra Tele Productions Pvt. Ltd., Silver Square Building, 5<sup>th</sup> Floor, Christian Basti, P.O & P.S. Dispur, Guwahati 5 Assam.

It is not understood whether the RTI petitioner or 2<sup>nd</sup> appeal petitioner are same or not. Further, the absence of the petitioner at the hearing is also not justified without any reason.

6. In light of it, if the PIO falls under the RTI Act,2005 and the information is not barred by any court order or under exemption, then the sought for information to be given to the petitioner.
7. The case is disposed off.
