## O R D E R 04/08/2022

- 1. The petitioner Shri Harinarayan Pathak has filed one RTI petition before the SPIO of Guwahati Metropolitan Development Authority, Bhangagarh, Guwahati 05 on 18.4.2022 seeking following information:
  - (i) Copy of each and every work order issued from GMDA during the period w.e.f. 1.4.2017 till 31.3.2022.
  - (ii) Copy of each and every administrative approvals and sanction letters as received from the Competent Authority against each respective work orders, as referred to at query no (i) above.
  - (iii) Status of the work order as referred to at the query no.(i) above in documentary proofs as on 18.4.2022 against each respective Works Order.
- 2. Reportedly on not getting any information, the petitioner filed 1<sup>st</sup> appeal before the First Appellate Authority, GMDA, Bhangagarh, Guwahati 781005 on 21.5.2022 and then he filed 2<sup>nd</sup> appeal before the Commission on 30.6.2022.

Accordingly, the matter was taken up for hearing.

- 3. The petitioner Shri Harinarayan Pathak is present.
- 4. The Public Authority is represented by Shri Mrinmoy Lekharu, Assistant Executive Engineer, GMDA.
- 5. The SPIO of GMDA has submitted a written statement dated 3.8.2022 wherein it is mentioned that the sought for information has already been furnished on 13.7.2022 but the petitioner vide his letter dated 1.8.2022 mentioned that the information was at random and clubbed together.
- 6. In light of the above, the Commission orders the petitioner to visit the office of Guwahati Metropolitan Development Authority, Bhangagarh, Guwahati and clarify what he means by "clubbed together" and get the necessary information accordingly.

The SPIO to take steps in addressing his grievances.

7. The case is disposed off.
