ORDER 28/07/2022

- 1. The petitioner Sri Indra Ballav Goswami has filed one RTI petition before the PIO, O/o the Deputy Commissioner, Golaghat, Assam on 29.12.2021 seeking some information as per enclosures.
- Reportedly on not getting any information, the petitioner filed 1st appeal before the 1st Appellate Authority, O/o the Deputy Commissioner, Golaghat, Assam on 11.2.2022 and then he filed 2nd appeal before the Commission on 6.6.2022. Accordingly, the matter was taken up for hearing.
- 3. The authorised representative of the petitioner advocate Sri Bhaskar Ballav Goswami has submitted his Vakalatnama to attend the hearing today.
- 4. The Public Authority to be represented by SPIO, O/o the Deputy Commissioner, Golaghat is absent without any intimation.
- 5. As per Section 7 of the Right To Information Act, 2005, the SPIO simply gets thirty days to furnish the information to the petitioner and similarly 1st Appellate Authority also gets thirty days to respond to the RTI petition. In this particular case, no information/reply was furnished to the petitioner as per the provisions of the RTI Act,2005.
- 6. <u>Therefore</u>, the Commission would like to seek an explanation from the SPIO O/o the Deputy Commissioner, Golaghat, Assam why no penalty u/s 20 of the RTI Act,2005 should not be imposed on him for not furnishing the information on time.

Explanation if any should reach within fifteen days from the receipt of this letter.

7. The case is disposed off.
