O R D E R 02/08/2022

- 1. The petitioner has filed non-compliance petition regarding Commission's order dated 21.3.2022 before the Commission on 19.5.2022 and accordingly, the matter was taken up for hearing.
- 2. The petitioner Shri Joydeb Das is present.
- 3. The Public Authority is represented by Shri Shantanu Dhar, Deputy Commissioner of Taxes and SPIO.
- 4. This case was disposed vide Commission's order dated 21.3.2022 with specific instruction to the SPIO to submit specific reply to the petitioner.
- 5. However, due to non-receipt of the reply during the stipulated time, the petitioner filed the non-compliance before the Commission.
- 6. The petitioner stated that there has been inordinate delay in complying with the order and he has not got the information.
- 7. The SPIO stated that due to non-receipt from the concerned branch the reply could not be submitted in time but the information is ready and he has handed over the copy to the petitioner
 - The SPIO apologized for the delay.
- 8. The Commission expresses unhappiness on the fact that the late submission of information has made the Commission to conduct the hearing unnecessarily and the hearing process wasted the time and resources of the Commission and the Government.

However the Commission takes a lenient view for this time.
