1. The petitioner filed a complaint against non-compliance of Commission's order dated 27.9.2021 before the Commission on 14.2.2022 and accordingly the matter was taken up for hearing today.
2. The petitioner Sri Joydeb Das is present.
3. The Public Authority is represented by Sri Subrata Roy Bardhan, ACS, Additional Secretary, Agriculture Department, Dispur
4. The petitioner has said that the enquiry report is contradictory and has not mentioned on production of training related voucher, trainees of APR list etc etc., as sought by him vide RTI petition dated 18.2.2020.
5. On this, the Commission asked the enquiry officer Sri Subrata Roy Bardhan, ACS Additional Secretary, Agriculture Department, Dispur about the point raised in the Commission order dated 27.9.2021 particularly relating to point no.5 and 6.
6. The Enquiry Officer Sri Subrata Roy Bardhan, ACS, Additional Secretary, Agriculture Department, Dispur prays before the Commission to allow him ten days more time to conduct a specific enquiry into the points raised by the petitioner vide non-compliance letter dated 11.4.2022 (copy enclosed) and RTI petition dated 18.2.2020 (copy enclosed).

The Commission takes a lenient view and allows 10 days more time w.e.f today to Sri Subrata Roy Bardhan, ACS, Additional Secretary, Agriculture Department, Dispur to complete the enquiry and submit the report to this Registry as well as furnish the information as per the RTI petition to the petitioner.
