**O R D E R**

19.05.2022

The appellant Sri Anupam Hazarika through his e-mail dated 18.05.2022 informed the Commission that he has received the desired informations from the SPIO, o/o the District Social Welfare Officer, Lakhimpur except few copies of challans pertaining to Bordoloni ICDS Project. It is also submitted that he had a telephonic discussion with the DSWO, Lakhimpur and has requested him to furnish the remaining informations as soon as possible.

The i/c DSWO, Lakhimpur vide his letter no. DSWO(NL)410/2017/Pt-III/2263 dated 18.05.2022 submits before the Commission that the informations i.e. challans/bills which has received from the CDPOs of the districts had already been furnished to the appellant except some missing challans of Bordoloni ICDS Project. It is submitted that the remaining informations challans/bills will be furnished as soon as it is located.

The Director-cum-FAA, Social Welfare, Assam has submitted written statement vide letter no. DSW(RTI)G/21/2021/25 dated 12.05.2022. It is informed that on receipt of the 1<sup>st</sup> appeal petition dated 07.02.2022 of Sri Anupam Hazarika, he had a telephonic discussion on the RTI Branch of the District Social Welfare Officer, Lakhimpur and directed to furnish the sought for informations at the earliest. He received a copy of the letter from the DSWO, Lakhimpur through e-mail dated 28.02.2022 and came to know that the informations had already been furnished to the appellant.

It is seen that most of the sought for informations had already been received by the appellant except a few copies of challans/bills of Bordoloni ICDS Project. **Therefore, the SPIO, o/o the District Social Welfare Officer, Lakhimpur is directed to furnish copies of rest of the informations to the appellant as soon as it is located.**

**With the above directions, the 2<sup>nd</sup> appeal dated 28.03.2022 is disposed of.**
