O R D E R 28.04.2022

The appellant Sri Anser Ali is present.

Md. Rowshan Ali Khan, Headmaster, Paisty Aironjongla M.E. School is also present.

Perused the case record. The appellant submitted one application dated 03.05.2021 under the RTI Act, 2005 before the SPIO, o/o the BEEO, Gauripur seeking some informations. The BEEO, Gauripur transferred the said application to the said Headmaster, Paisty Aironjongla M.E. School through his letter no. GB/RTI-216/19-20/523 dated 06.05.2021 with a direction to furnish the informations directly to the petitioner. The appellant submitted another letter no. nil dated nil to the BEEO, Gauripur Education Block. The sought for informations has not been furnished to him. Subsequently, he submitted 1<sup>st</sup> appeal petition dated 25.10.2021 before the DEEO, Dhubri and 1<sup>st</sup> appellate authority. On receipt of the same, the DEEO, Dhubri organized hearing on 30.11.2021 and disposed of the same with a direction to the Headmaster of Paisty Aironjongla M.E. School to furnish complete informations within fifteen days. This order was issued vide no. EED-318/RTI/FA/2020/646 dated 25.03.2022. Still the appellant did not receive the desired informations for which he submitted 2<sup>nd</sup> appeal dated 21.02.2022 before the Commission. During the time of hearing today, the Headmaster of the same said school submits orally that he has furnished the informations to the appellant by hand but the appellant declined to receive the same.

On query, the appellant submits orally that the informations furnished by the said school are not proper for which he has not received the informations provided by him but he can't explain how he came to know that the informations furnished by the Headmaster of Paisty Aironjongla M.E. School is not proper. Further, it is seen that he has sought informations in respect of classwise enrollment of students along with parents name and address duly certified and details of Mid Day Meal allotment yearwise from 2017-2020 along with total quantity lifted, expenditure incurred and fund received along with updated bank passbook and other bills and vouchers for the period from 2017-2020.

It is observed that the sought for informations are large in number. Therefore, the appellant is directed to inspect all records of the desired informations and take copy to his requirement. The Headmaster, Paisty Aironjongla M.E. School is directed to invite the appellant on a mutually convenient date and facilitate him for inspection of the records of the informations. He will furnish upto 50 copies of informations free of cost to the appellant and for the rest, the appellant will pay as per prescribed rate for the cost of photocopying.

With the above directions, the  $2^{nd}$  appeal dated 21.02.2022 is disposed of.
