**O R D E R**

09.05.2022

The appellant is absent.

The SPIO, o/o the CDPO, Mahamaya ICDS Project is absent without step.

The Programme Officer, Divisional ICDS Project, Kokrajhar and 1<sup>st</sup> appellate authority has not submitted written statement on action taken to dispose of the 1<sup>st</sup> appeal petition.

Perused the case record. The appellant submitted one application dated 29.09.2020 under the RTI Act, 2005 before the SPIO, o/o the SDO(C), Bilasipara. The same was transferred by the SPIO, o/o the SDO(C), Bilasipara to the SPIO, o/o the CDPO, Mahamaya ICDS project. The petitioner did not receive the desired informations within the stipulated period of time and submitted 1<sup>st</sup> appeal petition dated 03.11.2020 before the FAA, o/o the SDO(C), Bilasipara. The SDO(C), Bilasipara forwarded the 1<sup>st</sup> appeal petition to the FAA and Dist. Social Welfare Officer, Dhubri. Still the appellant was not provided with the sought for informations for which he submitted 2<sup>nd</sup> appeal dated 18.01.2021 before the Commission.

Seen the RTI application dated 29.09.2020. It is observed that the desired informations are large in number, and for a long period from 2012 to 2020. **Therefore, the CDPO, Mahamaya ICDS Project is directed to invite the appellant within seven days of receipt of this order on a mutually convenient date for inspection of the records of the sought for informations. The SPIO is also directed to issue a formal letter to the appellant for inspection of the records and to give copies of the desired informations. The entire process of inspection and issue of informations should be completed within two days.**

**With the above directions, the 2<sup>nd</sup> appeal dated 18.01.2021 is disposed of.**
