The appellant/complainant vide his e-mail dated 13.05.2022 requests the Commission to re-fix another date of hearing as he is out of station for health reason.

Smti. Kalpana Deka, Addl. Deputy Commissioner and SPIO, o/o the Deputy Commissioner, Kamrup(M) is present. The SPIO has submitted written statement vide letter no. RTI/case no. 79/2021/235 dated 12.05.2022 but materials of the written statement is found to be related with another case.

Seen the case record. The appellant submitted one application dated 23.09.2021 under the RTI Act, 2005 before the SPIO, o/o the DC, Kamrup(M) seeking certain informations. As he did not receive the desired informations within the stipulated period of time, he submitted 1<sup>st</sup> appeal petition dated 16.11.2021 before the 1<sup>st</sup> appellate authority, o/o the DC, Kamrup(M). It is observed that the SPIO has not furnished informations in response to petition dated 23.09.2021. The FAA also did not organize hearing to dispose of the 1<sup>st</sup> appeal petition dated 16.11.2021.

Therefore, the Commission directed the FAA, o/o the DC, Kamrup(M) to submit written statement in response to Commission's Notice bearing no. SIC/KP(M).402/2021/9 dated 09.02.2022.
