Accordingly, he has handed over some informations to the appellant during the course of hearing. He submits orally that he is unable to furnish the copy of sought for proceeding book of meeting and bill vouchers for non-availability of the same in the office. He further submits orally that records of these informations had not been handed over to him by his predecessor and he has not informed about the same either to the Deputy Commissioner, Golaghat or CEO, Golaghat Zilla Parishad.

**Therefore, the SPIO is directed to collect the above stated records from his predecessor and furnish the desired informations to the appellant within seven days of receipt of this order, free of cost.**
