**O R D E R**

26.05.2022

The appellant Sri Atul R. Marak is present.

The Secretary & SPIO, Kalpani Chandamari GP and SPIO of Balijana Dev. Block are absent without information.

The CEO, Goalpara Zilla parishad and 1<sup>st</sup> appellate authority has not submitted written statement in respect of action taken to dispose of the 1<sup>st</sup> appeal petition dated 08.02.2022.

Perused the case record. The appellant submitted one application dated 09.12.2021 under the RTI Act, 2005 before the SPIO, Balijana Dev. Block seeking certain informations. The BDO, Balijana Dev. Block forwarded the same to the Secretary of Kalpani Chandamari GP with a direction to furnish the informations directly to the appellant but the appellant did not get the desired informations for which he submitted 1<sup>st</sup> appeal petition dated 08.02.2022 before the CEO, Goalpara Zilla Parishad. The CEO, Goalpara Zilla Parishad and FAA organized hearing against 1<sup>st</sup> appeal petition but no order is seen to have been issued.

The appellant submits orally that although hearing for 1<sup>st</sup> appeal was organized yet no order was passed. Thereafter, he preferred 2<sup>nd</sup> appeal dated 21.03.2022 before the Commission.

Seen the RTI application dated 09.12.2021. The sought for informations are very much part of the record that should be maintained by the Secretary of Kalpani Chandamari GP under Balijana Dev. Block. **The SPIO and Secretary of Kalpani Chandamari GP is directed to furnish the desired informations to the appellant within seven days of receipt of this order, free of cost.**

**With the above directions, the 2<sup>nd</sup> appeal dated 21.03.2022 is disposed of.**
