**O R D E R**

The appellant Smti. Dipshikha Mahanta is present.

Sri Rajiv Neog, Associate Planner and deemed PIO of GMC is present. He is assisted by Sri Kapil Dev Choudhury, Zonal Engineer of GMC. The PIO of GMC has submitted written statement vide letter no. GMC/RTI/FAA/03/2022/14 dated 01.06.2022.

Perused the case record. The appellant submitted one application dated 21.11.2021 under the RTI Act, 2005 before the PIO of GMC seeking certain informations. She did not receive the desired informations within the stipulated period of time and submitted 1<sup>st</sup> appeal petition dated 21.12.2021 before the PIO of GMC. Still she did not receive the desired informations and as such preferred 2<sup>nd</sup> appeal dated 28.03.2022 before the Commission.

The PIO through his written statement submitted that the desired informations had already been furnished to the appellant vide letter no. GMC/RTI/FAA/03/2022/1550 dated 22.02.2022.

Seen the informations furnished to the appellant. It is stated that the sought for informations are not on record.

On query, the deemed PIO submits orally that records of building permission are not maintained categorywise for which they are not in a position to furnish the informations in respect of building permission given to various Nursing Home and private schools within GMC area.

In my opinion, it is desirable that GMC should maintained records of private schools and Nursing Home for which building permission had been granted by them.

**The SPIO of GMC should take up the matter with the Commissioner, and furnish the desired informations once and if the records are maintained accordingly.**

**With the above directions, the 2<sup>nd</sup> appeal dated 28.03.2022 is disposed of.**
