<u>O R D E R</u> 07.06.2022

The appellant Sri Ashrafuddin Ahmed is present.

Sri Fulchand Ali Ahmed, Secretary, No. 65 Kurihamari Borchuliya GP under Barkhetri Dev. Block is present. Smt. Rita Rani Mahanta, SPIO of Barkhetri Dev. Block is also present. The SPIO submits written statement vide letter no. BDB/RTI/II/2020-21/Pt-VII/9408 dated 07.06.2022.

Perused the case record. The appellant submitted one application dated 29.12.2021 under the RTI Act, 2005 before the PIO and Secretary of No. 65 Kurihamari Borchuliya GP seeking certain informations. He did not receive the desired informations within the stipulated period of time and submitted 1st appeal petition dated 19.02.2022 before the BDO of Barkhetri Dev. Block. Still he did not receive the desired informations for which he submitted 2nd appeal dated 19.04.2022 before the Commission.

Seen the RTI application dated 29.12.2021. From a plain reading of the application, it is observed that the sought for informations are very much part of record to be maintained by the GP Secretary.

On query, the GP Secretary, Sri Fulchand Ali Ahmed submits orally that he has not received full charge of the GP from his predecessor for which he is not in a position to furnish all the required informations timely. However, he has collected all the required informations and tried to hand it over to the appellant but the appellant declined to receive the informations and demanded to get it signed by the GP Secretary.

The Commission directs the SPIO and Secretary, No. 65 Kurihamari Borchuliya GP to furnish the copies of informations to the appellant as it has been maintained in its office within seven days of receipt of this order.

With the above directions, the petition dated 19.04.2022 is disposed of.
