Seen the case record. The appellant submitted one application dated 23.09.2021 under the RTI Act, 2005 before the SPIO, o/o the DC, Kamrup(M) seeking certain informations. As he did not receive the desired informations within the stipulated period of time, he submitted 1st appeal petition dated 16.11.2021 before the 1st appellate authority, o/o the DC, Kamrup(M). Still he did not receive the desired informations and he submitted complaint petition dated 13.12.2021 before the Commission.

Seen the written statement submitted by the SPIO, She submits that the sought for informations had already been furnished to the appellant through letter bearing no. DDMAK(M)11/2013/154 dated 28.02.2022. She also produces a copy of letter upon which the complainant has signed on receipt of the informations.

Since the informations are furnished, and the complainant receives the same, hence the petition dated 13.12.2021 is disposed of. However, the SPIO, o/o the DC, Kamrup(M) is hereby cautioned not to make delay in furnishing informations against any RTI petitions in future.
