<u>O R D E R</u> 01-04-2022

- 1. The appellant Shri Iftikar Ali Pathan is present.
- 2. The SPIO, O/o the Secretary, Alitangani Jamuguri GP, Nagaon, is absent. The Commission has received a letter from the PIO, O/o the Secretary, Alitangani Jamuguri G.P. dated 29.03.2022 stating that he is unable to attend today's hearing due to verification and registration of PMAY-G houses coinciding with the hearing today. He has also submitted few pages of written statement.
- 3. From records it is seen that Shri Iftikar Ali Pathan had submitted one RTI application on 23.08.2021, addressed to the PIO, P&RD Department, Nagaon, but submitted to the O/o the Deputy Commissioner, Nagaon, in which he had requested for some informations related to Alitangani Jamuguri G.P. under Juria Development Block. On 11.10.2021 the President, Alitangani Jamuguri G.P. wrote a letter to the appellant Shri Iftikar Ali Pathan stating that he was unable to furnish the informations due to non-availability of staff in his office as all of them were transferred. But he also stated that the information will be provided after the reappointing of the staff. On 29.10.2021 the appellant submitted a 1<sup>st</sup> Appeal in the O/o the BDO, Juria Development Block. On 15.11.2021 a hearing was held on the 1<sup>st</sup> Appeal and the PIO, O/o the Secretary, Alitangani Jamuguri G.P. was directed to furnish the information directly to the appellant within 7 (seven) days. On not receiving any response the appellant submitted a 2<sup>nd</sup> Appeal in this Commission on 13.12.2021.
- 4. During today's hearing when it was pointed out that the PIO, O/o the Secretary, Alitangani Jamuguri GP has mentioned in his written statement that all information has been furnished, the appellant Sjri Iftikar Ali Pathan said he had only received information related to query No. 1. In view of this the PIO, O/o the Secretary, Alitangani Jamuguri G.P. is directed to furnish informations sought under query No. 2 of the RTI application to the appellant Shri Iftikar Ali Pathan within 15 (fifteen) days from the date of receipt of this order, free of cost. The PIO shall also obtain an acknowledgement receipt from the appellant.
- 5. With the above order, this  $2^{nd}$  Appeal is hereby disposed of.
