O R D E R 04-04-2022

- 1. The appellant Shri Atul R Marak is present.
- The SPIO, O/o the BDO, Krishnai Development Block is absent. But the Commission has received a letter dated 02.04.2022 from the BDO, Krishnai Development Block stating that information related to Krishnai, Fafonga, Meshelkhowa, Tukurabormohora and Jira Gaon Panchayats has been provided to the appellant Shri Atul R. Marak on 02.04.2022.
- 3. From records it is seen that the appellant Shri Atul R Marak on 28.04.2021 submitted one RTI application to the SPIO, O/o the BDO, Krishnai Development Block seeking certain informations related to the Krishnai, Fafonga, Meshelkhowa, Tukurabormohora and Jira Gaon Panchayats. While he had received informations related to the Krishnai, Meshelkhowa, Tukurabormohora and Jira Gaon Panchayats. He had not received informations related to Fafonga G.P. and hence have submitted an Appeal in this Commission on 25.11.2021.
- 4. During today's hearing however the appellant Shri Atul R Marak stating that he has been furnished with the informations relating to Fafonga G.P. on 02.04.2022. The written statement received from the BDO, Krishnai Development Block also collaborates to this. The appellant Shri Atul R marak said he has now received all the informations.
- 5. In view of the above, this 2nd Appeal is hereby disposed of without any order.
