O R D E R

The appellant Sri Shohidul Islam is present.

Sri Himangshu Kr. Das, Sub-Inspector, FCS & CA Branch, o/o the Deputy Commissioner, Barpeta is also present as authorized by the SPIO & Deputy Director of the office.

Perused the case record. The appellant submitted one application dated 11.01.2022 under the RTI Act, 2005 before the SPIO, o/o the FCS & CA branch, o/o the DC, Barpeta. He did not receive the desired informations within the stipulated period of time and submitted 1st appeal petition dated 07.03.2022 before the DC, Barpeta and 1st appellate authority. The ADC and FAA, o/o the DC, Barpeta arranged hearing against the 1st appeal petition and passed order on 30.03.2022 directing the Deputy Director, FCS & CA branch to furnish the desired informations within three days which was disposed on 30.03.2022. The appellant did not receive the desired informations even after passing of the order by the FAA for which he preferred 2nd appeal dated 23.05.2022 before the Commission.

Seen the RTI application dated 11.01.2022. The appellant sought for informations for a period from 2017 to 2021 which seems to be large in number. **The SPIO, o/o the DC, Barpeta, FCS & CA branch is directed to invite the appellant within seven days of receipt of this order and facilitate him to inspect the records of the sought for informations. He will further furnish him 50 (fifty) pages of informations free of cost and if the appellant wants to take more than 50 (fifty) pages, then, he will pay the photocopying cost as per prescribed rate. The inspection of records and furnishing of informations should be completed within three days from its start.**

With the above directions, the 2nd appeal dated 30.03.2022 is disposed of.
