O R D E R

1. The petitioner Shri Joydeb Das has filed one RTI petition before the PIO, Chief Engineer PWD (Road), Chandmari, Guwahati 03 on 4.5.2022 seeking following information:
 - (1) Please furnish whether PWD (Road) has floated tender for “ Construction of RCC Bridge No.6/2 on Chamaria Sontoli Road under Rural Infrastructure Development Fund (RIDF) – XV” during the period 2009-10 to 2010-11. If yes, please furnish following details:
 - (a) Please furnish on which based the rate was adopted for preparation of estimate for all items along with estimate cost of work and fund released.
 - (b) Please furnish a copy of technical sanction, NIT, Work Order, Comparative Statement of price bid and bill.
 - (c) Please furnish a copy of Measurement Book of Structural Steel Truss.
2. Reportedly on not getting any information, the petitioner filed 1st appeal before the First Appellate Authority, O/o the Chief Engineer PWD (Roads), Chandmari, Guwahati on 13.6.2022 and then he filed 2nd appeal before the Commission on 26.7.2022.

Accordingly, the matter was taken up for hearing.
3. The petitioner Shri Joydeb Das is present.
4. The Public Authority is represented by Shri Sushil Kumar Das, PIO cum SE(P), O/o the Chief Engineer, PWRD.
5. The petitioner said that he has received all information except Question No.1 (a) and 1 (b). On which the SPIO replied that reply to question no. 1(a) is based on the rate adopted in the year 2007-08 and reply to question no.1(b) the SPIO stated that the information is voluminous and few 100 pages, so the SPIO desires to give the information to the petitioner in pendrive.
6. Therefore the Commission directs the petitioner to provide a new pendrive to the SPIO and collect the information accordingly.
7. The case is disposed off.
