- 1. In continuation of earlier order dated 31.5.2022, the matter was taken up for hearing.
- 2. The petitioner Shri Joydeb Das is present.
- 3. The Public Authority to be represented by SPIO, Directorate of Vigilance & Anti-Corruption is absent.
- 4. The SPIO cum Superintendent of Police (I), Directorate of Vigilance& Anti-Corruption, Assam, Srimantapur, Guwahati has submitted a written statement dated 22.8.2022 wherein it is mentioned that he will not be able to personally appear before the Commission on 23.8.2022 as directed due to pre-occupation with some urgent work.

In the written statement the SPIO also mentioned that the RTI Applicant Shri Joydeb Das has mixed up the matter of Anonymous Enquiry as referred in his RTI application No. NIL, dated 24.8.2021 and Anonymous Cases as referred in his RTI application dated 7.2.2022. The Directorate of V & AC Assam did take up Anonymous Enquiries for conducting enquiries by Officers of this Directorate. But this Directorate did not take up or registered any Anonymous Case during the sought for period.

- 5. The petitioner when told about the reply in point no.4 of the written statement, intimated that the reply is vague ambiguous and not clear. He further stated that had the SPIO been present this could have been clarified.
- In light of the above, <u>the Commission has decided to fix another date of hearing</u> and directs the SPIO to be present on the next date of hearing and clarify the <u>contents of the written statement</u>.
