1. The petitioner Md. Touseif Hussain Reza has filed one RTI petition before the In-charge of the office, O/o the Deputy Commissioner, Kamrup(M), Guwahati on 26.4.2022 seeking following information:
Application for Inheritance Mutation (Pending application at Chandrapur Circle Office) Annexure 1
Application for reclassification of KP Patta Land. Annexure 2.
(1) Please provide the daily progress made on the above mentioned application and the application attached as Annexure 1 and 2 of the RTI application submitted at the below mentioned office –
 - a. Chandrapur Circle Office
 - b. The Deputy Commissioner, Kamrup Metro.
(2) Please state the reasons behind delaying the process and holding the mentioned application
(3) Please provide the action taken reports on the applications so mentioned.
(4) Please provide the date and time required to complete disposal of the application.
(5) Please provide the steps taken to ease the process in the terms of the documentation.
(6) Name and designation of the officials who have considered my application and the number of days it was lying with each official during this period.
(7) Please provide copies of file noting indicating the consideration of my application from the date of receipt till date by the concerned officials. (I would also like to inspect all documents related to each case)
(8) A copy of the rules/ regulations/ orders/ citizens charter which lay down the timeline for disposal of matters.
(9) Name and designation of officials who are responsible for dereliction of duty for delaying my application in violation of relevant rules/regulations/ orders. (If applicable).
(10) (i) Date by when action would be completed in my case?
(ii) Period for which information asked for 1987-2022.
2. Reportedly on not being satisfied with the information received, the petitioner filed 1st appeal before the 1st Appellate Authority, O/o the Deputy Commissioner, Kamrup (M), Guwahati, Assam on 3.6.2022 and then he filed 2nd appeal before the Commission on 7.6.2022.
Accordingly, the matter was taken up for hearing.
3. The petitioner Md. Touseif Hussain Reza is present.
4. The Public Authority is represented by Shri Nirmal Jyoti Sarmah, Assistant Commissioner, Kamrup (M) accompanied by Shri Krishna Arjun Barman, Assistant Settlement Officer, Chandrapur Re-Settlement.

5. The SPIO, O/o the Deputy Commissioner, Kamrup (M), Guwahati has submitted a written statement dated 4.8.2022 wherein it is mentioned that the sought for information has already been furnished the petitioner on 20.6.2022.
6. The petitioner pointed out that he has filed on behalf of the handicapped person with power of attorney and wanted to know when the survey process will be completed? The question of rescheduling of survey process in particular is not within the purview of this Commission, the Commission directs the petitioner to treat this case separately.
7. The case is disposed off.
