O R D E R 25/08/2022

- The petitioner Shri Harinarayan Pathak has filed one RTI petition before the Staff Officer to the Chief Secretary and SPIO, O/o the Chief Secretary, Govt. of Assam, Dispur, Guwahati on 23.3.2022 seeking following information:
 - (1) Office DY. No. & Date in respect of the petition dated 30.5.2022 submitted by Shri Harinarayan Pathak addressed to the Chief Secretary, Govt. of Assam, Dispur being delivered on 2.6.2020 through Speed Post Article No. E 9792960544IN Dated 1.6.2020 in documentary proof.
 - (2) Copy of the Public Document with official records thereon, as referred to at query No (1) above.
 - (3) Action taken report supported by Documentary proofs including respective File Notings, in respect of the Public Document as referred to at the Query No. (1) above.
 - (4) Status of the Public Document as referred to at the query no.(1) above, as on 23 .3.2022.
- 2. The Staff Officer to Chief Secretary, Dispur, Guwahati forwarded the RTI petition to the Principal Secretary to the Govt. of Assam, Personnel Department, Dispur on 5.4.2022 with a direction to furnish the information directly to the petitioner.
- 3. Reportedly on not getting any information, the petitioner filed 1st appeal before the First Appellate Authority, Personnel (A) Department, Dispur on 9.5.2022 and then he filed 2nd appeal before the Commission on 22.7.2022.

Accordingly, the matter was taken up for hearing.

- 4. The petitioner Shri Harinarayan Pathak is absent.
- 5. The Public Authority is represented by Shri Dharani Dhar Das, Deputy Secretary & SPIO, Personnel (A) Department.
- 6. The SPIO has submitted a written statement dated 24.8.2022 enclosing a letter dated 26.5.2022 wherein the petitioner was called for inspection and collection of the documents to which the petitioner did not respond.
- 7. The Commission in examining the RTI petition, it is found that the 2nd appeal petition is in his response to his RTI petition dated 23.3.2022. And as intimated by the SPIO, the petitioner is not responding to the letter of the SPIO.
- 8. In light of the above, the Commission orders the petitioner to visit the SPIO, clarify the petition and inspect the documents if any and collect the information accordingly.

9. The case is disposed off.
