## <u>O R D E R</u> 25/08/2022

- 1. The petitioner Shri Harinarayan Pathak has filed one RTI petition before the SPIO, Guwahati Metropolitan Development Authority, Bhangagarh, Guwahati on 30.4.2022 seeking following information:
  - (1) Action Taken Report supported by Documentary Proofs including respective File Notings in respect of thee Public Document, vide letter No. GPL/Misc/50/2014/7 issued from the Associate Planner, GMC addressed to the Town Planner, GMDA under sub: Violation of Building NOC of Sainik Bhawan by Converting Parking Place to Office/Canteen, in respect of NOC Bearing No. GMDA.BP/2858/18122009/36 Dated 20.5.2010.
  - (2) Status of the Public Document, as referred to at the Query No.1 above, in documentary proofs as on 30.4.2022.
- 2. The SPIO of GMDA then sent a reply to the petitioner on 23.5.2022 furnishing the sought for information.
- 3. Reportedly on not being satisfied with the information received, the petitioner filed 1<sup>st</sup> appeal before the First Appellate Authority, GMDA, Bhangagarh, Guwahati on 13.6.2022 and then he filed 2<sup>nd</sup> appeal before the Commission on 25.7.2022.

Accordingly, the matter was taken up for hearing.

- 4. The petitioner Shri Harinarayan Pathak is absent.
- 5. The Public Authority to be represented by SPIO, O/o the Guwahati Metropolitan Development Authority is absent without any intimation.
- 6. Since both the parties are absent, the Commission had decided to hear the matter again.
