ORDER 25/08/2022

- 1. The petitioner Shri P.K.Choudhury has filed one RTI petition before the Commissioner of Police, Guwahati, O/o the Commissioner of Police, Panbazar, Guwahati on 14.3.2022 seeking following information:
 - (1) Name and designation of all police personnel posted in the Gitanagar Police Station as on 1.1.2022 indicating the date on which they joined the post.
 - (2) If any of these personnel have been posted earlier at Gitanagar Police Station, the date of joining and relinquishment of post to be given for all such posting/postings subsequent to 2004.
- 2. The SPIO, O/o the Commissioner of Police, Guwahati then sent a reply to the petitioner on 25.3.2022 wherein the SPIO has mentioned that the information cannot be furnished u/s 8(1)(a)(g)(h) of RTI Act,2005.
- Reportedly on not being satisfied with the information received, the petitioner filed 1st appeal before the First Appellate Authority, O/o the Commissioner of Police, Panbazar, Guwahati on 18.4.2022 and then he filed 2nd appeal before the Commission on 25.7.2022.

Accordingly, the matter was taken up for hearing.

- 4. The petitioner Shri P.K.Choudhury is present.
- 5. The Public Authority to be represented by SPIO, O/o the Commissioner of Police, Guwahati is absent.
- 6. However, the SPIO has submitted a written statement dated 23.8.2022 which is taken into records.
- 7. Since the SPIO is absent, the Commission has decided to hear the matter again.
- 8. Fix **5.9.2022 at 11:15 AM** as the next date of hearing.
