## 01.07.2022

The complainant Sri Saman Ali Sk is present.

The Sub-Registrar, Bilasipara through his e-mail dated 01.07.2022 informs the Commission that the sought for informations had already been furnished to the petitioner Sri Saman Ali Sk vide letter no. BSR.1/2021/27 dated 11.04.2022. He also attaches written statement bearing letter no. BSR.1/2021/24 dated 30.06.2022.

Perused the case record. The complainant Sri Saman Ali Sk submitted one application dated 22.03.2022 under the RTI Act, 2005 before the SPIO, o/o the Sub-Registrar, Bilasipara seeking some informations. The Sub-Registrar, Bilasipara furnished the informations through its letter bearing no. BSR.1/2021/27 dated 11.04.2022 but the petitioner was not satisfied with the informations so received and submitted complaint petition dated 28.04.2022 before the Commission.

The contention of the complainant is that informations furnished by the Sub-Registrar, Bilasipara are not believable since informations given by the Sub-Registrar, Bilasipara to the effect that one letter copy of which is sought by the applicant is not traceable in his office. It is clear that he has not denied the informations but his declaration is that the information is not available in his office. In the 2<sup>nd</sup> point, the applicant desires to have copies of all the non-judicial stamp paper (both sides) which were issued by the stamp vendor outside the district of Dhubri, and were registered in the o/o the Sub-Registrar, Bilasipara from the month of January, 2019 to March, 2022. The public authority informs the petitioner that no such record is maintained in the office.

The Commission considers that the replies given by the Sub-Registrar, Bilasipara is not denial of informations and as such the petition dated 28.04.2022 is disposed of.
