The appellant Sri Abdul Goffar Talukdar is present.

The Secretary & SPIO, Umarpur Gaon Panchayat under Badarpur Dev. Block is absent without step.

The CEO, Karimganj Zilla Parishad has not submitted written statement in respect of action taken to dispose of the 1st appeal petition.

Perused the case record. The appellant Sri Abdul Goffar Talukdar submitted an application dated 13.12.2021 under the RTI Act, 2005 before the SPIO & Secretary of Umarpur Gaon Panchayat under Badarpur Dev. Block seeking some informations. He did not receive the sought for informations within the stipulated period of time and requested the Block dev. Officer of Badarpur Dev. Block through application dated 05.02.2022 that he has not been provided with the informations by the Secretary of Umarpur GP. Still he did not receive the desired informations and submitted 1st appeal petition dated 15.03.2022 before the CEO of Karimganj Zilla parishad. Being dissatisfied for not receiving the informations, he preferred 2nd appeal dated 26.05.2022 before the Commission.

Seen the RTI application dated 13.12.2021. **The informations sought for should be part of record to be maintained by the Secretary of Umarpur GP. Since he has not submitted any written statement nor is present, therefore, he is directed to furnish the sought for informations to the appellant within seven days of receipt of this order.**

The CEO of Karimganj Zilla parishad is directed to ensure that the informations are furnished by the Secretary & SPIO, Umarpur GP as directed.

With the above directions, the 2nd appeal dated 26.05.2022 is disposed of.
