## ORDER 05.07.2022

The appellant is absent without step.

Smti. Kalpana Deka, Addl. Deputy Commissioner & SPIO, o/o the Deputy Commissioner, Kamrup(M) is present.

Perused the case record. The appellant submitted one application dated 03.09.2021 under the RTI Act, 2005 before the SPIO, o/o the Deputy Commissioner, Kamrup(M) seeking certain informations. He did not receive the desired informations within the stipulated period of time and submitted 1<sup>st</sup> appeal petition dated 06.10.2021 before the 1<sup>st</sup> appellate authority, o/o the DC, Kamrup(M). The FAA disposed of the 1<sup>st</sup> appeal by an order directing the Member, MACT Kamrup to furnish the informations directly to the petitioner within seven days of receipt of the order dated 10.01.2022 but the petitioner still did not receive the informations for which he preferred 2<sup>nd</sup> appeal dated 15.02.2022 before the Commission.

The ADC & SPIO, DC's office, Kamrup(M) submits orally that the informations had been furnished to the appellant vide letter no. KNB16/2011(Pt)/21-23 dated 16.06.2022 through registered post.

Since the sought for informations had been furnished by the SPIO, o/o the DC, Kamrup(M) and the appellant is not present to raise contention, if there be any, hence the 2<sup>nd</sup> appeal dated 15.02.2022 is disposed of.
