Smt. Anushree Das, Sub-Divisional Fishery Dev. Officer, Directorate of Fisheries is present. Sri Himangshu Bora, Project Manager and SPIO, Assam Fisheries Dev. Corporation Ltd. is also present.

Sri Himangshu Borah submits orally that hearing of 2<sup>nd</sup> appeal had been taken by the Chief Information Commissioner in case no. SIC/KP(M)244/2022 and has been disposed of accordingly. He further informs that since the matter has been settled and disposed of by the CIC on the very same subject and very same application, so there is no need to hear this case again.

Perused the case record. Also seen the case record of case no. SIC/KP(M)244/2022 and that of SIC/KP(M)204/2022 which are all the same including the reference no. given by the appellant but he submitted two different  $2^{nd}$  appeal application putting date of appeal on 16.05.2022 and 02.05.2022 in the verification sheet.

It is observed that Sri Kirtikamal Bora has misled the Commission submitting two different 2<sup>nd</sup> appeal application on the same RTI application dated 20.12.2021 addressing to the PIO, o/o the Directorate of Fisheries, Assam. Therefore, the Commission warns the appellant Sri Kirtikamal Bora not to mislead the Commission in future, else action will be initiated against him.

With the above directions, the  $2^{nd}$  appeal dated 02.05.2022 is disposed of.
