The appellant Sri Atul R Marak is present.

The Executive Engineer & SPIO, DRDA, Goalpara had submitted written statement vide letter no. RDGLP-5/RTI/2018-19/204 dated 01.07.2022.

Perused the case record. The appellant submitted one application dated 22.11.2021 under the RTI Act, 2005 before the PIO, Goalpara Zilla Parishad seeking some informations. The application was transferred by the PIO of Goalpara Zilla Parishad to the PIO, o/o the Project Director, DRDA, Goalpara. The PIO, o/o the PD, DRDA, Goalpara transferred the RTI application to all the BDOs of Goalpara dist. with a direction to furnish the sought for informations to the appellant directly. For non-receipt of the sought for informations, the appellant submitted 1st appeal petition dated 21.03.2022 before the 1st appellate authority of DRDA, Goalpara. Still he did not receive the desired informations for which he preferred 2nd appeal dated 26.05.2022 before the Commission.

On query the appellant submits orally that he has received some informations from the PIO of Lakhipur, Krishnai and Kharmuja Dev. Block. He is yet to receive the informations from the other dev. Blocks of the district. He further submits that informations so received from three dev. Blocks are not complete and satisfactory.

Therefore, the Commission directs the SPIOs of all Dev. Blocks i.e. Jaleswar/Matia/Rongjuli/Kharmuja/Kushdhowa/Lakhipur and Krishnai to furnish the sought for informations to the appellant within seven days of receipt of this order. The Project Director, DRDA, Goalpara is directed to ensure that the above order is complied with.

With the above directions, the 2nd appeal dated 26.05.2022 is disposed of.
