**O R D E R**

11.08.2022

The appellant Sri Binose Phura is present.

Sri Promod Shyam, Deputy Director, FCS & CA, Diphu and SPIO is present. Sri Long Kumar Engti, Inspector of FCS & CA, Hamren Division who was i/c Deputy Director, FCS & CA, Diphu during the period from 30.09.2020 to 30.04.2021 is present and submits written statement vide letter no. nil dated nil. It is submitted that he is not aware of the RTI petition dated 06.12.2021 of Sri Binose Phura which was received by one senior assistant of the office who did not put it up to him. The 1<sup>st</sup> appeal petition dated 19.01.2022 was received by the office but was not put up for which he could not furnish the desired informations to the appellant.

Perused the case record. The appellant submitted one application dated 06.12.2021 under the provision of RTI Act, 2005 before the PIO, o/o the Deputy Director, FCS & CA, Diphu seeking some informations. He did not receive the desired informations within the stipulated period of time and submitted 1<sup>st</sup> appeal petition dated 19.01.2022 before the 1<sup>st</sup> appellate authority, o/o the Deputy Director, FCS & CA, Karbi Anglong, Diphu. Still he did not receive the informations for which he preferred 2<sup>nd</sup> appeal dated 02.03.2022 before the Commission.

Seen the petition dated 06.12.2021. The appellant desires to have informations in respect of (i) sale registers of all retailers and dealers of all LAMPS under Diphu Division, (ii) Ration Cards of all LAMPS. Both the present SPIO and the Deputy Director, FCS & CA, Diphu submits orally that the informations in respect of point number 1 of the application, their office is not the custodian and only the sale registers of all retailers and dealers of LAMPS under Diphu Division are retained by the respective retailers and dealers of fare price shops and ration cards of LAMPS are retained by the consumers only, and it is not kept in their office. **Therefore, the Deputy Director, FCS & CA, Karbi Anglong, Diphu is directed to take appropriate action under the provision of the RTI Act, 2005 so that the appellant get the informations of point number 1 within 10 (ten) days of receipt of this order. If copies of ration card can't be furnished to the appellant it should be informed accordingly with**

**proper reason. He is further directed to take proper action against the erring officials for negligence of whom the SPIO was not aware of the RTI application as well as 1<sup>st</sup> appeal.**

**With the above directions, the 2<sup>nd</sup> appeal dated 02.03.2022 is disposed of.**
