The complainant is absent.

Md. Mahabub Mollah, Senior Assistant as authorized by the Circle Officer, Bilasipara Rev. Circle is present. He has submitted one letter bearing no. BPC-3/2020/Pt-II/746 dated 27.07.2022. It is submitted that the desired informations had already been furnished to the appellant.

Perused the case record. The complainant submitted one application dated 06.05.2022 under the provision of RTI Act, 2005 before the SPIO of Bilasipara Rev. Circle seeking certain informations.
